Role Assignments:

Freestyle level skaters usually have two roles, and basic level skaters one role.

We do our best to assign skaters different roles from year to year, but skill levels for roles may change depending upon the skaters who are available at each level.

- ◆ Skaters **cannot** miss more than one practice, which must be excused.
- ◆ Skaters **must** attend the rehearsal on December 3rd.
- ◆ Skaters **must** attend one of fitting times scheduled in October.
- ◆ Skaters are expected to attend a scheduled photo shoot, in costume, Nov. 4th.

Restrictions/Conflicts: If you know that you will have a restriction or conflict of any kind, you **must** use the back of this form to explain the restriction/conflict **and** understand that this will affect the roles for which you are eligible. For example, you may need to be assigned to a role that you have skated before at the same skill level, or to only one role even if you are a freestyle level skater.

Individual Release Agreement

Your signature on the front of this form means that you have read the below text and that you understand the terms and stipulations as described and agree to all of them. I am entering into this Agreement with the Ice Chalet and its agents. I have been informed and understand that the Ice Chalet (Producer) is producing a video and photographs, and that my/my child's name, likeness, image, voice, appearance, and performance is being recorded and made a part of that production and photo/video collection ("Products").

The Products are **The Nutcracker On Ice DVD, Photos, and Marketing Materials/Services.**

1. I grant the Ice Chalet and its designees the right to use my/my child's name, likeness, image, voice, appearance, and performance as embodied in the Products whether recorded on or transferred to CDs, DVDs, film, slides, photographs, other media now known or later developed. This grant includes without limitation the right to edit, mix, or duplicate and to use or re-use the Products in whole or in part as Producer may elect. Producer or its designee shall have complete ownership of the Products in which I/my child appear, including copyright interests, and I acknowledge that I have no interest of ownership in the Product or its copyright.

2. I also grant Producer and its designees the right to broadcast, exhibit, market, sell, and otherwise distribute the Products, either in whole or in part, and either alone or with other products, for commercial or non-commercial television or theater, closed-circuit exhibition, home video distribution, or any other purpose that Producer or its designees in their sole discretion may determine. This grant includes the right to use the Products for promoting or publicizing any of the uses or future productions.

3. I confirm that I have the right to enter into this Agreement, that I am not restricted by any commitments to third parties, and that Producer has no financial commitment or obligations to me as a result of this Agreement. I hereby give all clearances, copyright and otherwise, for the use of my/my child's name, likeness, image, voice, appearance, and performance embodied in the Products.

4. I expressly release and indemnify Producer and its officers, employees, agents, and designees from any and all claims known and unknown arising out of or in any way connected with the above granted uses and representations. The rights granted Producer herein are perpetual and worldwide.

NOTE: Private Videoing (for Personal Use) Permission & Limitations

A professional videographer will video the Friday evening and Saturday evening performances. By agreement with the videographer, private videoing (for personal use) of these two performances is *not* permitted.

Restrictions -- STRONGLY DISCOURAGED!

Using this section is strongly discouraged unless absolutely necessary because it limits the roles we can assign to you. This is show business; your inability to participate or any restriction you have on your participation affects other skaters in the show. Tell us if you have any performance or rehearsal conflicts or other restrictions that we should keep in mind when assigning your roles. NOTE: If you inform us of a change or restriction after the entry form due date, we have the option to remove you from a role.
