

Freestyle level skaters usually have two roles, and basic level skaters one role. We do our best to assign skaters different roles from year to year, but skill levels for roles may change depending upon the skaters who are available at each level.

- Skaters *cannot* miss more than one practice, which must be excused.
- Skaters must attend one/both rehearsals on Mon., Nov. 27 & Tues. Nov. 28.
- Skaters must attend one of the fitting times scheduled for Oct. 8, 14, and 15.
- Skaters are expected to attend the Cast Photo Session on Sunday, Nov. 5th.

Restrictions/Conflicts: If you know that you will have a restriction or conflict of any kind, you must use the back of this form to explain the restriction/conflict and understand that this will affect the roles for which you are eligible. You may need to be assigned to a role that you have skated before, or to only one role even if you are a freestyle level skater.

Individual Release Agreement

Your signature on the front of this form means that you have read the below text and that you understand the terms and stipulations as described and agree to all of them. I am entering into this Agreement with the Ice Chalet and its agents. I have been informed and understand that the Ice Chalet (Producer) is producing a video and photographs, and that my/ my child's name, likeness, image, voice, appearance, and performance is being recorded and made a part of that production and photo/video collection ("Products").

The Products are The Nutcracker On Ice Videos, Photos, and Marketing Materials/Services.

1. I grant the Ice Chalet and its designees the right to use my/my child's name, likeness, image, voice, appearance, and performance as embodied in the Products whether recorded on or transferred to CDs, DVDs, digital files, drives, film, slides, photographs, other media now known or later developed. This grant includes without limitation the right to edit, mix, or duplicate and to use or re-use the Products in whole or in part as Producer may elect. Producer or its designee shall have complete ownership of the Products in which I/my child appear, including copyright interests, and I acknowledge that I have no interest of ownership in the Product or its copyright.

2. I also grant Producer and its designees the right to broadcast, exhibit, market, sell, and otherwise distribute the Products, either in whole or in part, and either alone or with other products, for commercial or non-commercial television or theater, closed-circuit exhibition, home video distribution, or any other purpose that Producer or its designees in their sole discretion may determine. Restrictions -- STRONGLY DISCOURAGED!

Using this section is strongly discouraged unless absolutely necessary! It will limit the roles we can assign to you. Especially for freestyle level roles, your inability to participate on even one night, or any restriction you have on your participation, affects other skaters in the show. Tell us if you have any performance or rehearsal conflicts or other restrictions that we should keep in mind when assigning your roles. NOTE: If you inform us of a change or restriction after the entry form due date, we have the option to remove you from a role.

Tentative practice times for roles are listed below. There will usually be one practice per week per role assigned, perhaps two per week closer to show dates.

Reason for restriction/conflict:
